Hope you are well.

Given the date that we are at after all the pre apps etc, I'd say there is a fair chance that we will have to do 20% Part V. I'm assuming an RFI from CCC and a probable appeal from someone.

Given that, can I suggest the attached.

This is based on the original Part V where we were proposing Duplex and 2B Terrace to satisfy Part V (26 Homes).

We are now with redesigns and various changes at 262 Homes (20% will be 52 Homes).

Can I propose we include the smallest of the 3 B Terrace Homes to make up the difference along with an additional 8 Duplex. I would also propose two end of terrace 3 Beds.

Predominantly, the extra houses are a small bit larger than the 2B's mainly proposed initially to satisfy 10%. 1046 sq ft. as opposed to 913 sq. ft.

Hope you are well. Apologies, sent you an earlier message that I recalled as it had an error.

We are getting close to closing off layout discussions with planning at present on the Next Phase of our lands up in Ballyvolane (current layout attached).

We are at 261 Homes in total which at 10% puts us at 26 Homes to Part V at 10%.

We have 55 apartments but would like to leave them as a separate sub phase for delivery right now so are leaving them out of calculations.

If we do this, we would be delivering all the 2 bed homes to CCC Part V and 6 of the 14 duplexes; the remainder 8 duplex are part of the Apartment Area.

This would see;

1. 6 Duplex by Bus Stop
2. Rest are houses...

On this basis we can deliver 20 of the 22 no. 2 Beds Homes and 6 duplex (to meet 10% Part V). If we have to do a higher number of Part V we would most likely have to deliver 3 Bed terraces. The 3 Beds are a small bit larger than the 2 beds we are currently building.

Appreciate the explanation is a bit convoluted. Happy to chat.
